- The Republic of Chad has developed an operational institutional framework for matters relating to the environment and allowed to finalize and to approve a number of sectoral strategy documents

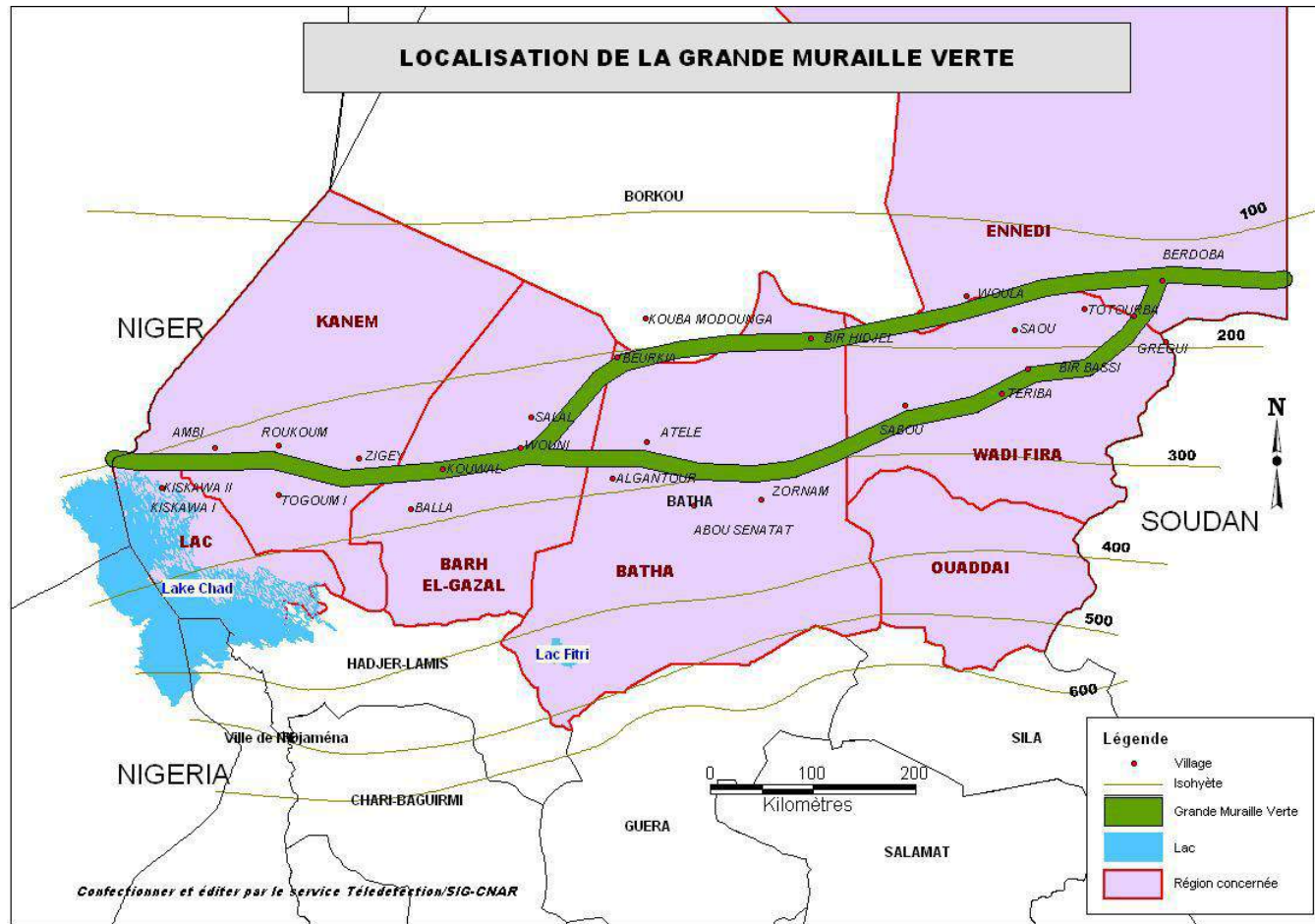
Genesis of Green Great Wall Initiative

- The Great Green Wall Initiative (GMV) is a transcontinental project of the African Union in response to environmental challenges related to climate change and the effects of desertification.
- The Great Green Wall is designed as a set of interventions on the restoration of natural resources and the fight against poverty while promoting synergy of actions for biodiversity conservation, fight against desertification and recovery potential of agrosilvopastoral areas
