Agroecological practices are essential to improve soil health, crop resilience, and food security, while supporting farmer's livelihoods. This includes promoting soil health, biodiversity, and economic resilience. Likewise, we provide training, technical assistance, and market access. GOB Menorca also monitors program impact and collaborates with other organizations to advocate for policy changes that support sustainable agriculture globally. Activities and/or practices employed (within 50 words) Some examples of what we do: - Agricultural resilience: soil samples to asses soil health, directed grazing, water use efficiency. - Commercial resilience: excursions to farms as promotional strategy, tasting events, promoting the Custòdia Agrària brand. - Environmental resilience: diverse actions focused on enhancing biodiversity. - Training and individual consulting. Monitoring methodology (e.g. GIS-based monitoring, citizen science, Resilience Indicators in SEPLS, survey - within 40 words) -Questionnaires on economic evolution of the participating farms. -Citizen science: yearly monitoring of bioindicators (plants, butterflies and beetle presence in manure) -Yearly farmers meetings where a summary of the actions conducted that year is presented and farmers express their concerns, needs and wants for the next year. -Carbon capture investigation. Results (within 50 words) The Custòdia Agrària program effectively assists farms in adopting sustainable practices. While quantifying results beyond activity inventories is challenging, the program's success is indicated by increasing farm participation, farmer satisfaction and social percepcion. However we are working on improving monitoring in order assess the effectiveness of interventions quantitatively. Lessons learned (factors in success or failure, challenges and opportunities - within 40 words) -Establishing networks with resonant initiatives is essential to exchange knowledge and best practices. -Participatory processes are crucial for implementing robust and efficient interventions. -Staff resources are crucial to ensure impact -The increasing number of participant farms demands more efficiency and improved monitoring.
