Gaoshi Village is a Paiwan indigenous tribe surrounded by mountains on all sides. The interaction between the Gaoshi tribe members and the natural environment has led to the evolution of unique cultural practices specific to the tribe, including food, clothing, building materials, and festivals.
Description of human-nature interactions in the area ( <i>land-use, traditional resource management practices etc. – within 50 words</i> )
Gaoshi tribe is home to diverse plant species, with as many as 15 plants named after the area. The tribe developed a profound ethnobotany, incorporating over 200 plant species into their daily lives. However, due to the passage of time and environmental degradation, this cultural knowledge is gradually disappearing.

Due to environmental degradation and overuse, the number of native plants in Gaoshi tribe has decreased or disappeared. Moreover, the underdeveloped economy has also led young members to leave for work, hindering the transmission of traditional culture.			
Objectives ( <i>goals of activities or policies described, or of producing the case study – within 50 words</i> )			
The goal of this work is to restore the biodiversity of the Gaoshi tribe through plant restoration. It also integrates traditional Paiwan knowledge to create a sustainable value chain that attracts youths to return to their hometowns and preserves the cultural heritage of plant use in Gaoshi.			
Activities and/or practices employed ( <i>within 50 words</i> )			
The government and tribal residents have collaborated to implement the Gaoshi-Named Plants Return to Hometown Program, establishing a plant conservation area in the tribe to restore native plants. They also assist residents in engaging in under forest economy and homegardens, while developing eco-tourism with local and tribe culture features.			
Results ( <i>within 50 words</i> )			
The work restored 9 species of Gaoshi-named plants in the conservation area, while tribe members learned propagation and care techniques to ensure their growth. They have started to value indigenous plants, creating a sustainable industry chain based on traditional knowledge, which helps pass on the tribal cultural heritage.			
Lessons learned ( <i>factors in success or failure, challenges and opportunities – within 40 words</i> )			
The work emphasizes collaboration, covering all aspects from plant sourcing and propagation to reintroduction. It also integrates cultural knowledge, allowing younger tribe members to learn about traditional plant uses. These efforts revive the tribe's ethnobotanical culture and protect biodiversity.			
Key messages ( <i>within 40 words</i> )			
Through the integration of plant restoration and indigenous knowledge, Gaoshi tribe promotes biodiversity restoration and creates an eco-tourism demonstration area. It builds a sustainable value chain, achieving a balanced development of environment, society, and economy.
