*House of Maize* highlights how multidimensional alternatives preserve biocultural heritage against agrobiodiversity loss. Focused on *milpa* and native maize, it links production to consumption through agroecological practices, keeping economic and cultural benefits within the community and creating a local, circular, and equitable value chain.

Objectives (*goals of activities or policies described, or of producing the case study – within 50 words*)

Analyze a sustainable experience of value creation, from the *milpa* to the served plate.

Activities and/or practices employed (*within 50 words*)

a) Ecosystem restoration and conservation: production diversification, ancestral knowledge recovery and seeds preservation, b) Development of Sustainable Value Chains: local value chain and processing, direct marketing, c) Knowledge: revaluation and dissemination events, social recognition, education and awareness, c) Institutional frameworks: ethical construction, governance and political advocacy.

Monitoring methodology (*e.g. GIS-based monitoring, citizen science, Resilience Indicators in SEPLS, survey - within 40 words*)

"Citizen science" is implemented via Silks Agroecological Market Participatory Guarantee System. Producers and consumers collaboratively monitor and verify agroecological practices, fostering mutual trust and quality assurance for native corn products without third-party certification.

Results (*within 50 words*)

The project adds economic value (through environment care and products development), provides dignified work, promotes better, toxic-free nutrition, contributing to a dignified life. It also led to the multiplication of over 30 maize varieties, community strengthening through family networks, and greater economic and environmental resilience.

Lessons learned (*factors in success or failure, challenges and opportunities – within 40 words*)

**Key factors of success:** 1) links: family network strengthening, linkage with organizations and universities. 2) sovereignty: empowering families, dignifying work, and seed variety multiplication.

**Challenges:** educating new generations on agroecology and facing climate change threats.
