Unmanaged forests not only tend to lose their biodiversity among flora and fauna, but also pose a higher risk of landslides. Therefore, appropriate and continuous forest management is essential to maintain ecological integrity and mitigate disaster risks.

Objectives (goals of activities or policies described, or of producing the case study – within 50 words)

While advancing the conservation of forested areas through formal protection schemes, it is equally important to promote sound forest management practices. Accordingly, the municipal is undertaking initiatives for forest conservation, management, and utilization through collaborative efforts with local citizens / community.

As concrete initiatives for forest conservation, management, and utilization, the municipal is promoting three key approaches: (1) Community Woods program, (2) collaborative forest management, and (3) cultivation of high-quality forests based on the Forest Management Guidelines.

With the cooperation of landowners, the municipal has promoted the conservation of forested areas through initiatives such as Community Woods Program. In addition, through collaborative engagement with citizens, sound forest management practices have been advanced, and well-managed forests have been utilized as recreational spaces for the public.

Well-managed forests offer recreational opportunities tailored to the diverse lifestyles of citizens.
